Classification (refer to item 9). Sub Award is a 'Stand-Alone' one-time competition. Judging will also be base on the "Theme" concept.
- 8) **Event Format:**

All competitors are to submit their entries by November 2, 2008. Competition will comment from December 27 to 31, 2008. Competing vehicles are **not allowed** to withdrawn or remove for the total of 5 days event. Classes will judge accordingly between the 5 days event. Competing vehicle which exhibiting will be judged accordingly at their sponsor's booth.

**Cat "A" (Professional)**

  - Open for all.

**Cat "B" (Advance)**

  - Replacement on both bumpers.
  - All major accessories (Body Kits, Rims and Tires, etc) must not exceed 2 level from the original specifications.
    - o Original rims of 15 inches can be replaced to a limit of 17 inches
    - o Original body kits can be extended to a limit of additional 2 inches.

### **Cat "C" (Novice)**

- Cars from original showroom conditions / with lips-on.
- Any additional add-on kits (eg. Spoiler, carbon-fiber boot etc.) will be upgrade to Cat "B"

### **Cat "D" (Sub Awards)**

- Open to all.
- All competitors that take part in Category A, B and C will automatically be included in this category.
- This is a standalone competition. You are allowed to register for this solitary competition.

12) **Judging Criteria:** The Panel of Judges will be made up of:

- a. Professional Judges
- b. Sponsors of the event

Judges will be requested to judge various scoring sections as stated in the list below. Judging will be based on the followings:-

**Engine Bay, boot, Ice, Interior, Tires/Rims/Brakes**

- Cleanliness
- Assembly
- Concept
- Creativity

**Body Works**

- Creativity
- Concept
- Artwork (Stickers/Airbrush)

**Exterior**

- Overall Cleanliness
- Overall Concept
- Overall Creativity
- Overall Outlook

There will be 2 main criteria of judging for the all category: **Stage A & Stage B**. Stage A will be judge for the cleanliness, assembly and the concept of the participating car.

Both Stage ‘A’ & ‘B’ will each carry 50% of the overall scoring.

For the Stage B, contestants will need to **showoff** their car at judging area. Definition of the showoff is to engage all gadgets, audio (ICE system) and/or any other special effects with all doors, boot & bonnet etc.

\*Participants will be allocated a raw space to display their cars. No spotlight will be provided to support in the display of the cars. No engine started is allowed, competitors need to self-arrange for equipments instead\*

#### Best Award '08

Judging will be base on overall concept or theme, artwork, workmanship, color combinations. Result for best decal design award will be announced during finals of Autostyling Challenge Series 2008.

### 13) Rules & Regulation

1. Contestants are **NOT ALLOWED** to advertise any products, services or/and any form of commercial activities within the competition area. (Only allowed for event's Sponsors)
2. All participating vehicles need to report at Changi Exhibition Centre on December 26, 2008. Timing to be advised accordingly.
3. Participating vehicles that are being displayed at any commercial tents will be allowed to take part in the contest. Without having to re-locate the vehicle into the judging area.
4. All competing vehicles are to be displayed at the contesting area/commercial booths throughout the whole competition period. Contestants who failed to comply will be immediately disqualified and refunds shall not be entertained.
5. The competition will commence at \*1400hrs daily. All contestants **MUST** report to the management booth at **1230hrs SHARP**. Contestants that are late shall be penalized on the scoring results accordingly. Appeals to the Panel of Judges will be considered on a case to case basis. Judges' decision will however be final.  
  
*\* Timing may vary depending on individual. Contact the Event Secretary on the timing prior to the event.*
6. All contestants will be allocated sponsor stickers and are required to display them on the competing vehicles.
7. Closing date will be set on November 2, however only allow a max of 60 entries.
8. Participants are to sign in at organizer booth by the pre-assigned timing given be the Event Secretary. It is the competitor's responsible to obtain the timing for reporting from the Event Secretary.
9. The Organizer reserves its right to reject any application and/or entry and/or cancel any class in its sole and complete discretion. The Organizer reserves its right not to provide any explanation for any such rejection and/or cancellation.

Whilst the Organizer will take best efforts to ensure the well-being of all participants and its vehicles for the duration of the competition, it shall not be held liable to any person for any loss, mortality, injury, sickness, damages and/or any harm whatsoever to the participant and/or its competing vehicle/s.
