2. Participating vehicles that are being displayed at any commercial tents will be allowed to take part in the contest without having to re-locate the vehicle into the judging area.
3. All competing vehicles are to be displayed at the contesting area/commercial tentages throughout the whole competition period in every individual round/heats. Contestants who failed to comply will be immediately disqualified and refunds shall not be entertained.
4. **All finalist vehicles must be ready at event venue 1 hour before the commencement of the competition.** Late comers shall be penalized on the scoring results accordingly. Appeals to the Panel of Judges will be considered on a case to case basis. Judges' decision will however be final.
5. All finalists are allowed to leave the event venue on 28<sup>th</sup> October 2006, Saturday, after the end of the event (2200hrs). However, finalists must be present and ready at the event on the following day, 28<sup>th</sup> October 2006, Sunday, by 0900hrs. Late-comers who failed to report to the registration will be penalized on the scoring results accordingly.
