4. **Jurisdiction** This Event is held under the International Sporting Code of the FIA and the National Competition Regulations 2003 of the Singapore Motor Sports Association (SMSA).

11. **Type of Event** An all-tarmac surface event for cars competing over straight line course covering a distance of 201m (1/8 mile) for The Sprint. Cars will compete for the fastest timing.  
  
The SuperSprint will include a figure-of-8 pattern within the course. Sharing of car is allowed but subject to a maximum of 2 entries per class per car.  
  
Off-road cars on the SMSA register are allowed provided they are towed to and from the venue. Non-user cars are not permitted unless prior approval has been obtained from the authorities.
12. **Eligibility** SMSA members and members of its affiliated clubs who are in possession of SMSA Competition Licenses valid for Race/Rallies in restricted grade and above

13. **Championship Points** SMSA Championship points will be awarded to winners in Class 10 (Open Class) for the SuperSprint 2007.
14. **Technical Regulation** Refer to SMSA Regulation for the year 2003, Section II, except for class 10a & class 20 (refer to SMSA in-charge personnel or the organiser.)
15. **Prizes** Trophies to be presented to the top 3 position, with the minimum of at least 6 entries in every class. 4<sup>th</sup> position trophy will be awarded for classes with minimum of at least 8 entries. 5<sup>th</sup> position will be awarded for classed with 10 entries and above.
- Fastest Time of the Day for Turbo and NA entries – 1<sup>st</sup> position:-  
Trophy + 1 set Bridgestone RE01R 15” or 16” or 17” Tyre.
- Knock-out winner for Turbo and NA entry – 1<sup>st</sup> position:-  
Trophy + 1 set Bridgestone RE01R 15” or 16” or 17” Tyre.
