Cat "A" (Professional)

- Open for all.

Cat "B" (Advance)

- Replacement on both bumpers.
- Front & rear fenders (not exceeding 2 inches)
- Rims not exceeding 2 inches from original.
- Interior designs will not be taken into consideration for classifications.

Cat "C" (Novice)

- Cars from original showroom conditions / with lips-on.
- Interior designs will not be taken into consideration for classifications.
- Any additional add-on kits (eg. Spoiler, carbon-fiber boot etc. will be upgrade to Cat "B"

Best "Award"

- Open to all.

Note: Exhibitors will have the privilege of having their cars being judged at their respective booths.

The top 3 positions (Classes) in all heats will qualify and compete in the final round (Tentatively to be held on November 4, 2007)

Individual categories will not be open until minimum of 5 entries are registered per category. Maximum of 10 entries will be allowed for each category of each heat. Otherwise, contestant will have the option of competing in the next heat/other classes/category or entry fees be refunded in full.

Contestant who took part in any of the category will automatic entitled to participate in the best award category.

13 Judging Criteria:

Judging System will be based on the following:-

1. Professional Judges
2. Sponsors of the event
3. Members of the public will be invited to make up part of the Panel.

Judges will be requested to judge various scoring sections as stated in the list below. Judging will be based on the followings:-

Engine Bay, boot, Ice, Interior, Tyres/Rims/Brakes

- Cleanliness
- Assembly
- Concept
- Creativity

Body Works

- Creativity
- Concept
- Artwork (Stickers/Airbrush)

Exterior

- Overall Cleanliness
- Overall Concept
- Overall Creativity
- Overall Outlook

There will be 2 main criteria of judging for the **all category: Stage A & Stage B**. Stage A will be judge for the cleanliness, assembly and the concept of the participating car. For the Stage B, contestants will need to **showoff** their car at judging area. Definition of the showoff is to engage all gadgets, audio (ICE system) and any other special effects with all doors, boot & bonnet open. Contestants will need to perform at least a minimum of a 3-minutes song of any track. Once over, judges will announce the scores for stage B individually. Sound quality will not be part of judging points.

Best Race Car Concept Award '07Overall Outlook

Judging to be base on Race Car Concept theme, exterior outlooks, any additional decals or stickers, as well as color combinations will take up the key aspect in this section's category.

Interior

All necessary mechanisms added, being dummy or otherwise, such as N.O.S, fire extinguisher, racing seats, 4-point belt, roll-cage, etc. The considering factor will be base on the complete equip of a 'Race Car'. Additional points will be allocated for Complexity and Beauty.

Engine Bay

Basic cleanliness of the overall engine bay with other equipped systems or accessories such as the fuel regulator, Booster, Air Filter, etc. Brands of any of the systems or accessories will not be taken into consideration.

Best Decal Design Award '07

Judging will be base on overall decal concept or theme, decal artwork, decal workmanship, decal color combinations. Result for best decal design award will be announce at final of Autostyling Challenge Series 2007.

14. Rules and Regulation:

1. Contestants are **NOT ALLOWED** to advertise any products, services or/and any form of commercial activities within the competition area/service tentages/competition cars.
2. Participating vehicles that are being displayed at any commercial tentages, will be allowed to take part in the contest. Without having to re-locate the vehicle into the judging area.
3. All competing vehicles are to be displayed at the contesting area/commercial tentages throughout the whole competition period. Contestants who failed to comply will be immediately disqualified and refunds shall not be entertained.
4. The competition will commence at 1300hrs. Show-off session will start at 1530hrs. Vehicles that are late shall be penalized on the scoring results accordingly. Appeals to the Panel of Judges will be considered on a case to case basis. Judges' decision will however be final.
5. All contestants will be allocated sponsor stickers and are required to display them on the competing vehicles.
